## PROGRESS PRIDE FLAG

Dear BCP Councillors and Officers

I am a BCP resident, living in the Wallisdown & Winton West ward. I felt deeply offended, alarmed and distressed at seeing the so-called **Progress Pride Flag** being displayed outside the town hall and other LGBTQ+ emblems during this year's Gay Pride season.

By flying the "Progress Pride Flag", it is making a highly provocative and **controversial** statement by pushing an aggressive, **political** ideology and queer philosophy, **not shared by all political parties.**

### The Law

Permit me to remind BCP Council that According to *section 2(1) of the **Local Government Act 1986:***

*(1)A local authority shall not publish or arrange for the publication of any material which, in whole or in part, appears to be designed to affect public support for a political party –*

*(2) whether the material refers to a political party or to persons identified with a political party or promotes or opposes a point of view on a question of **political controversy** which is identifiable **as the view of one political party and not of another**; where the material is part of a campaign, the effect which the campaign appears to be designed to achieve.*

*(3)A local authority shall not give financial or other assistance to a person for the publication of material which the authority are prohibited by this section from publishing themselves.*

A number of local political parties including the Christian People's Alliance (CPA) and the Reform party are committed to ending the socially divisive and wasteful promotion of LGBT ideology. The CPA's 2024 manifesto states that the party will:

"Slash all politically correct 'non-jobs' in the public sector and end the abuse of taxpayers' money for divisive woke political campaigning and indoctrination programmes." (CPA Manifesto 2024, p.9).

The Council's promotion of the Progress Pride Flag is taking a contrary position to that of the CPA and is lending support to the CPA's political opponents who seek expanded rights for transexuals and associated identities

The area of transgender rights is a highly contentious political issue in the United Kingdom. You will be aware that the Equality Act 2010 does not protect gender as a protected characteristic and that the Supreme Court recently ruled in the case of R(Elan-Cane) v Secretary of State for the Home Department [2021] UKSC 56 that non-binary identities - which are promoted by the Progress Pride Flag - are neither recognized, nor protected in UK law – for the simple reason that there is no scientific evidence for the existence of biological transsexuals. There is in fact no gay gene either. And yet schools have been brainwashed into believing that by government decree, they must indoctrinate and coerce students **into accepting a lie**. This is madness.

You will be aware that the Conservative Party has announced in its Manifesto that it intends to amend the Equality Act 2010 to remove any ambiguity which has seen the promotion of transgender rights to the detriment of people with protected characteristics and, in particular, to the rights of men and women to have access to single-sex spaces and sporting events (Conservative and Unionist Manifesto 2024, p.59). The CPA supports this position.

### **Victims of LGBTQ+**

For over two decades anyone, particularly Christians, making the slightest noise of dissent towards LGBTQ politics and ideology – which includes **abortion** - can expect to suffer adverse consequences, ranging from children **being bullied** in school, slanderous accusations, being publicly shamed with being awarded Stonewall's Bigot of the Year, arrest and being **assaulted** as happened to me, during the 2018 Bournemouth Gay Pride Parade.

Every parent like **Izzy Montague** whose child was forced to take part in a gay pride event has every **reason to fear** for the safety of their children from transgenderism and the act of sodomy, least of all because of the **health risks** associated with them. Ten year-old **Kaysey** who was in the same school as Izzy's child was **also expelled** for refusing to take part in the event. This is child abuse. Christian foster parents, **Eunice and Owen Johns** were deemed unfit to be parents by Derby City Council. The lesbian QC **Karon Monaghan** from the Equality and Human Rights Commission (initially established by Angela Mason, former Chief Executive of Stonewall who designed Stonewall's Luciferian logo, **the inverted pentagram**) warned that children **could be "infected"** by the moral views of Christian foster parents

People from all walks of life have been harassed by the police, lost their business and careers (as with the case of **Bernard Randall**), What happened to **Chris Windows**, Conservative Bristol Councillor and **nominated Mayor** of Bristol stands as a warning to all councillors in Britain for not bowing to totalitarian **pink law**. Freedom of conscience, thought and speech are under threat. Anyone who does not visibly or audibly stand in ovation of LGBTQs is accused of **homophobia** - an offence considered to be worse than mass murder.

Is this really what BCP councillors want for themselves?

### **The LGBTQ+ Agenda**

Whatever **meaning** BCP Councilors and officers might have given to the flag, they have clearly taken sides against the British people in a political, ideological and philosophical war. The real agenda of the LGBTQs has never been hidden. Since 1971 Peter Tatchell has openly declared that the **Gay Liberation Front** intended to abolish the family and **break down all boundaries** and restraints for LGBTs to get whatever they want, whenever, wherever and however they want to get it, irrespective of the rights of others! Founder of Stonewall Sir Ian McKellen and his LGBTQ followers as mentioned above have openly declared that their philosophy is to **subvert and smash the norm**. Elly Barnes of Educate and Celebrate, bragged of **smashing heteronormativity** in the home, the school and the community. The LGBTQ Leaders have told us they are seeking nothing less than for **world domination** - an LGBT caliphate.

People naively thought Michael Swift was joking in 1987 when he said the gays were going to corrupt and **sodomise our children**; but in 2023 the LGBTQs have finally and openly said [**WARNING**: offensive imagery] they are **coming for our children**.

It is time for BCP Council to choose whom it will serve, whether the side of the Lord or Lucifer and Stonewall.

### **Response required**

In light of the council's clear breach of the law, I am writing to demand as follows:

**i. All future Progress Pride Flags are immediately taken down from the council's premises**

**ii. Assurances are given that such flags will not be flown again and further that the council will not publicly support the ideological causes embodied by the flag including by taking part in public parades, demonstrations or providing financial support to any ideological campaigns. contrary to the positions of the CPA.**

I look forward to hearing from you by return for confirmation that the offending flags will never appear again on council property as requested.
